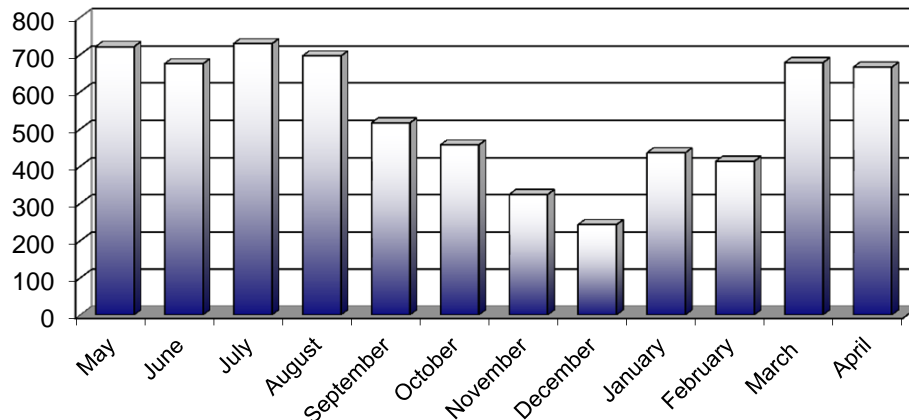

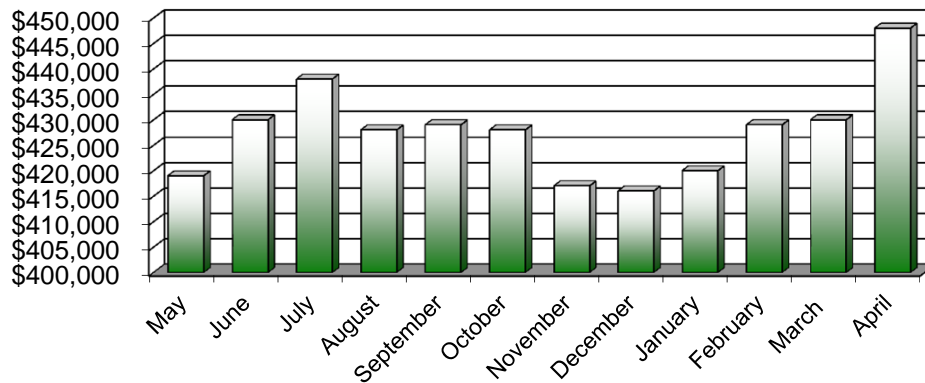

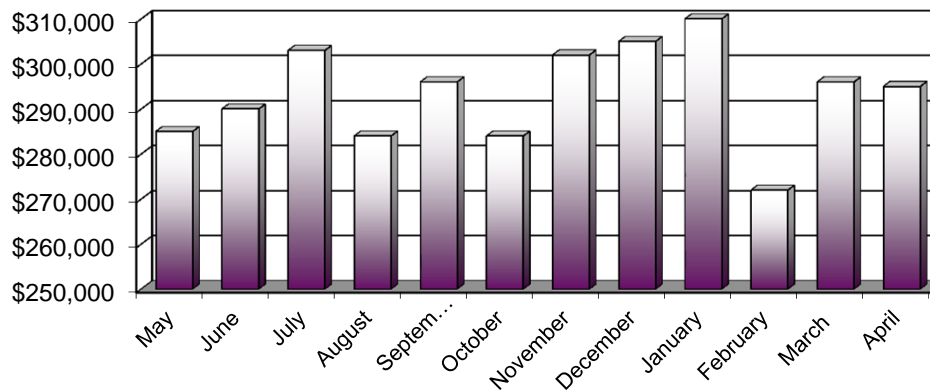
2013 - 2014 Average List Price

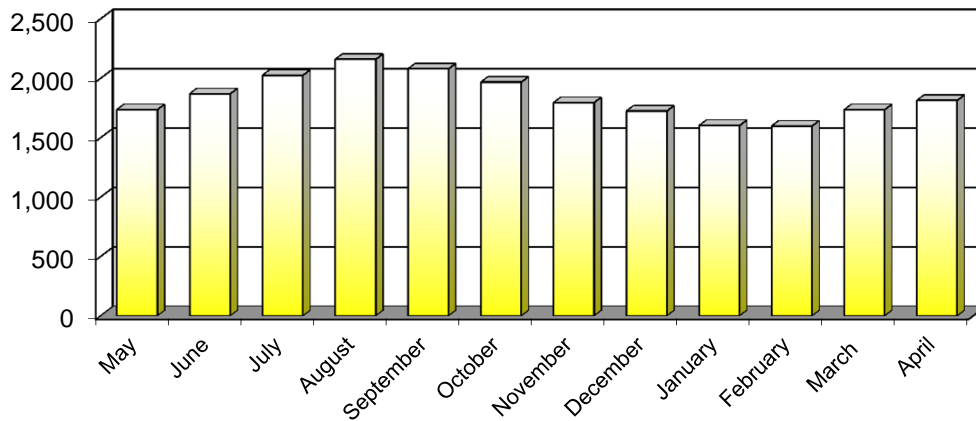

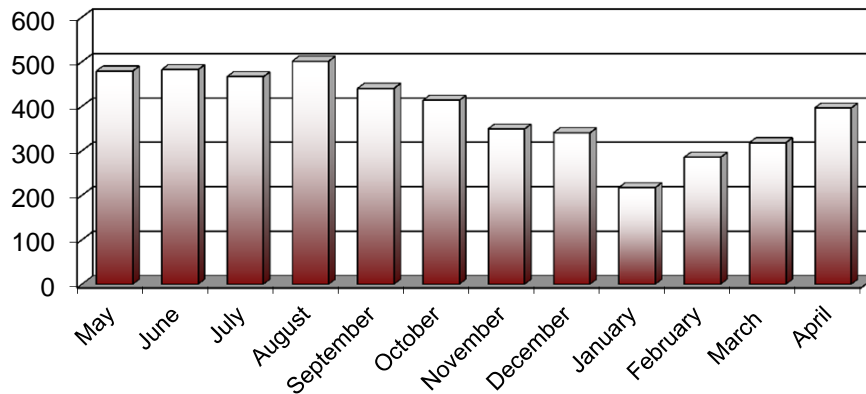
2013 - 2014 Total Homes Listed
